



2015 – Livestock – South Carolina State Fair – RV Camper Application & Regulations

Read before forwarding reservation form to the Fair.

Reservation forms must be received by October 3, 2015

No sleeping in vans, cars, cargo trucks/trailers or tents. Under penalty of South Carolina State Law, anyone found dumping gray or black water onto the ground, into the temporary lines not designated for black water, ditches, creeks or water ways will be fined and/or jailed based on South Carolina State statutes.

All sites are 10' wide and have water, sewer and electric. Electric is mostly 30 amps, with very few 50 amp connections available.

Regulations

- Reservations are required and must be received by October 3, 2015 (form attached). Check in is at Gate 5, you will be escorted to your area and shown your site. We are limited to 8 total RV/camper sites.
- All sites are 10' wide. Park between the lines with drivers side to the number on the breaker box, do not infringe on another site.
- Awnings cannot be used; slides can be used on one side only of an RV/camper not both sides. Again, do not infringe on another site.
- Charcoal, wood or open fires are prohibited. Gas grills are permitted as long as they are in an approved grill and you have a #2 or better fire extinguisher. The City of Columbia Fire Department will/may inspect all fires.
- Alcoholic beverages can only be consumed at your RV/camper. Disorderly campers will be asked to leave the grounds by the Richland County Sheriff's Department and/or the Director of Safety for the Fair.
- Do not park in any area of roadways marked "NO PARKING" or "FIRE LANES". Violators will have their vehicles towed at owner's expense.
- Pets are allowed, but must be kept on a leash or in a secured pen at all times. Please clean up after your pet. Richland County code section 5-6 & 5-16.
- The selling of goods or soliciting is prohibited on Fairgrounds property.
- We expect you to keep your camp site clean of trash and debris. If you can't keep it clean, we will ask you to leave.
- We have lots of buried pipes with water, electric and sewer in many areas of the Fairgrounds. Therefore, metal detectors are prohibited from being used on the property.
- The posting or soliciting of hand bills on vehicles or other parts of the Fairgrounds is prohibited by South Carolina law, City of Columbia and Richland Country.
- The use of a generator requires a stack.
- We reserve the right to revoke any permit for failure to abide by these rules and regulations or of the South Carolina Department of Health and Environmental Control. If a permit is revoked, no refunds will be issued and you must vacate the property immediately. 16-11-600 of the South Carolina Code of Laws.
- The South Carolina State Fair reserves the right to make a ruling on any questions not contained in these rules and regulations.

The South Carolina State Fair is not liable for any loss, theft or damages to any personal or real property or injuries sustained on the property. This property is under the jurisdiction of the Richland County Sheriff's Department.
