In addition to basic carpentry tools, contestants must bring the following items:

½" router, belt sander and/or finish sander

Cordless drills and screwdrivers are encouraged. (Powered miter saws are allowed)

Circular Saw

Sabre Saw/ Jig Saw

Reciprocating saw

Extension cords

Framing square

Compass

Chalk line

Safety Glasses with shields

Facemask

Leather work shoes

Hearing protection

**SAFETY STATEMENT:** All competitors must have the proper safety equipment as outlined in the *SkillsUSA Championships Technical Standards and* complete the attached safety form. Safety Glasses and hearing protection are required. *Instructor(s) must remain in the competition tent during the competition.* 

**NUMBER OF CONTESTANTS:** The first 25 SkillsUSA chapters to return the official registration form will be allowed to enter one team of two (2) contestants. Additional teams from previously registered teams will be accepted via a drawing if space allows.

<sup>\*\*</sup> All tools, equipment, and extension cords must be OSHA approved.

**PROJECT PLANS:** Will not be provided in advance.

**ENTRY FEE: \$40.00 per team entering the competition**. The registration must be accompanied by a check. Please register on-line at <a href="www.skillsusava.org">www.skillsusava.org</a>, go to Event, State Fair and then to Competitions. Substitutions may be made the day of the contest. *Note: Schools dropping participants after September 18 still owe the \$40 contest fee, to cover materials. Note: Project this year property of the sponsor.* 

**AWARDS:** Awards will be presented at the contest area.

**DEADLINE:** Schools must register the number of teams by September 22, 2017. Contestant names must be submitted to the State SkillsUSA Specialist by September 22, 2017. Substitutions may be made the day of the competition.

- Participants must have a Student Competition Ticket (\$6.15) to enter the Fairgrounds unless they are already at the Fair for another competition.
- Teachers are responsible for ordering tickets online by September 22, 2017 directly from the State Fair Ticket Office using a State Fair Student Competition Ticket Order Form, which can be found on-line at www.skillsusava.org under 'State Fair'
- Tool drop off, schools must have a 30 min. drop pass for vehicle entry, or contestants will have to carry in their tool boxes to the contest area. Passes maybe ordered when ordering State Fair tickets.

SAFETY REQUIREMENTS: ALL COMPETITORS MUST HAVE THE PROPER SAFETY
EQUIPMENT AS OUTLINED IN THE SKILLSUSA CHAMPIONSHIPS TECHNICAL STANDARDS

MUST BE SUBMITED TO THE CHAIRMAN AT REGISTRATION OF THE CONTEST.

CONTESTANTS ARE REQUIRED TO FURNISH & WEAR OSHA APPROVED PPE AND CLOTHING TO INCLUDE HARDHATS, LEATHER WORK BOOTS (do not have to be steel toe) AND SAFETY GLASSES WITH SIDE SHIELDS OR GOGGLES. CONTESTANTS WILL NOT BE ALLOWED TO COMPETE WITH TENNIS SHOES OR ATHLETIC TYPE SHOES.

A SAFETY MONITOR WILL BE OBSERVING THE CONTESTANTS DURING THE COMPETITION AND WILL STOP ANY CONTESTANT VIOLATING ANY SAFETY REGULATION. THE CONTESTANT WILL THEN ADJUST TO MEET THE REQIREMENTS OR BE DISQUALIFIED. THE SAFETY REQUIREMENTS WILL BE REVIEWED PRIOR TO THE START OF THE COMPETITION AND QUESTIONS WILL BE ANSWERED.
