SALE AGREEMENT:

1. I understand that when my livestock project is sold there will be charges deducted from my check including a 5% commission fee and species specific fees/assessments as mandated.
2. I understand that all beef, sheep, goat and swine consigned to the sale will be processed by the Salinas Valley Fair and resold by the contracted processor. Replacement Heifer sellers will be required to transfer cattle to buyers or reach out to the Salinas Valley Fair if additional assistance is needed.
3. I understand that market price for livestock will be established on the day of delivery to processors and will not be determined by the date of the auction sale or the date of delivery to the Salinas Valley Fairgrounds.
4. I understand that the sale of my market animal project is contingent upon Vet Inspection and Weight Requirements. If my animal is deemed not market ready by Veterinarian, I will not be able to participate in the Online Auction. I understand that I must follow all 4-H and FFA requirements to participate in the Online Auction. This includes requirements for meeting participation, grades or other terms agreed to by my club/chapter fair/animal project contract.
5. I understand that I am responsible for the care and health of my animal leading up to transfer of ownership.
6. I agree to provide photos, forms and marketing material in a timely manner in order for the success of the Online Auction.

DRUG STATEMENT:

1. No unauthorized chemicals have been used which would cause the carcass to fail USDA & FDA testing.
2. The withdrawal time required of any medication (including Medicated Feed) has been adhered.
3. I understand that all harvested animals are subject to inspection for drug residues and will hold the owner responsible for any unauthorized residues found in the carcass, resulting in a rejection of the carcass and will be liable for 3 times the amount the animal was sold for in the Online Auction.
4. I will complete and return the Medical Form two days before the required deliver date.
