## ARTHUR NAGEL COMMUNITY CLINIC

**GROUNDS:** Held in downtown Bandera on the Courthouse lawn. Show time from 10am to 5pm. Set up time begins at 7 am.

**ELIGIBILITY:** Open to individual artists and craftsmen presenting their original works. No

Manufactured, imported or resale items will be allowed **in the Arts and Craft area** – only original works and prints by exhibiting artists. Demonstrating your art or craft, while not required, will be a consideration when booths are being assigned. The Arthur Nagel Clinic reserves the right to reject any display that is not in keeping with the examples submitted.

**SELECTION PROCESS:** You may submit photos or web sites or samples of your work. Juried booths receive spaces in the front of the court house in high traffic areas. Commercial items are allowed but those spaces are typically located on the sides of the court house. Depending on the number of vendors that have applied.

**REGISTRATION:** The registration fee is \$50.00 per space for the one-day show. There will be no price limit on your items sold and no commission will be taken. All registration forms must be accompanied by photos, a web site or sample of your work, and a check or money order payable to Arthur Nagel Clinic. **Your check will not be cashed until you have been accepted into the show. Deadline for application February 12 , 2019.**

**SPACES/ ELECTRICITY:** Open spaces *only* are provided and are 10'x10'. You provide your own canopy. If you plan to use a canopy, tent, or umbrella, please specify and give dimensions. There are a limited number of spaces available. Electricity is available on a strictly limited basis at an

additional charge of \$10 per space, only to those **demonstrating** an art or craft. All circuits are Twenty Amps.

**NOTIFICATION OF ACCEPTANCE:** Artists will be notified of their acceptance no later than February **15th, 2019. You will receive an information packet no later than February 18th, 2019 by e-mail. There will be no refunds after February 1st, and no refunds should bad weather occur.**

The City of Bandera requires City Permits for all Vendors. To receive a permit, please call the City of Bandera at 830-796-3765. **PLEASE CALL THEM BEFORE 5PM ON THE WEDNESDAY BEFORE THE EVENT.** They will need you to send a copy of your **Driver's License** and your **Sales Tax ID**, along with a filled out **Vendor/Peddler City Permit Application** which they will e-mail to you or you can get online at [www.CityOfBandera.org](http://www.CityOfBandera.org)
