1. Before entering, refer to General Information and Youth Rules.
2. Exhibits must arrive on the grounds between 12-7 p.m. Sun., 8/19. Exhibits to be released between 8-10 a.m. Sun., 8/26.
3. Exhibits must be completed within this 4-H year. Exhibits must be part of a 4-H project.
4. All garments must have care information included. This could be a **permanently attached care label or a temporarily attached 3" x 5" card with written care instructions and how many years in project.**
5. Only six entries per project are allowed. Any article, outfit or educational exhibit is one entry. An outfit is two or more coordinated pieces of clothing.
6. Garments for Fashion Review may not be entered in this department.
7. Educational exhibit: posters 14" x 22" minimum, 22" x 28" maximum. Sample books 5" x 7" minimum with no maximum size. Attach a 3" x 5" index card to back of poster stating years and what you have learned in project.
8. Interview judging is encouraged for all 4-H clothing members entering clothing projects. 4-Hers will discuss the project with the judge (fabric, care, construction, techniques, etc.).
9. Interview judging will take place Sunday afternoon as the exhibits arrive. Be sure to have exhibitor's card prior to judging. Interviews will be according to junior, intermediate and senior.
10. All exhibits will be judged by the quality standards in "PNW 197, Measuring Up: Quality Standards for Sewn Items/Projects," available at the extension offices.
11. Sleepwear, sized 9 months – youth size 14 may be all cotton or cotton blend garments if they are form fitting. Youth gowns and robes (loose) must be made from flame retardant fabric to be labeled as sleepwear. Garments which are made from fabrics that are not considered flame retardant must be labeled and entered as loungewear. Infant sleepwear sized under 9 months are exempt as are adult sized garments.
12. DIVISIONS N – ZZ must be accompanied by the completed form C1065E – 4-H Quilt Entrance Questionnaire. <http://cru.cahe.wsu.edu/CEPublications/c1065e/c1065e.pdf> Also

in quilting divisions (N -ZZ), a quilted entry is defined as a textile article consisting of layers of fabric stitched together by hand or machine and machine or hand quilted with single tacking stitches or multiple stitching lines. Fabrics may be whole cloth or pieced. They may be embellished with fiber art techniques and/or found items (beads, charms, feathers, etc).
