If you qualify in 3D Open on more than 1 horse, you will have to choose which horse will advance to Challenge of Champions on Friday night, 8/10/18.

You must qualify on a horse that you wish to advance on.

Only 1 horse and 1 rider will compete for the title.

Ten riders will be in Friday night's Barrel Race.

An additional fee of \$20.00 must be paid after Wednesday's race to compete at the Championship Race on Friday night. Fee must be paid on Wednesday evening. If not, we will call the next qualified time on the list on Thursday.
