After June 7th, Post-Entry Fee: \$50.00 for Open, \$40.00 for Novice & Youth

Top 10 fastest times may advance to the Challenge of Champions on Saturday, June 15th at 7:30 pm.

Only one horse and rider will compete for the title. Ten riders will be in the program.
