This department is subject to all Boulder County Fair General Rules and all Open Class Creative Living Rules in addition to those listed for the department. It is the Exhibitor's responsibility to be familiar with all rules.

**RULES:**

1. Read Open Class Creative Living Rules and Boulder County General Rules and Regulations listed on the website.
2. Please note that monetary premiums will only be awarded for 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> place. There must be a minimum of 6 entries per class to be eligible for an award.
3. When filling out entry form, **Painting and Sculpture is Department 118.**
4. If item is For Sale, attach in inconspicuous place information on how to contact artist for price, etc.
5. All work must be ORIGINAL and not copies of paintings or published photographs.
6. Artwork must be ready for display, be dry, suitably framed and sufficiently wired for hanging-no saw tooth hangers and no bare glass edges. Painted gallery wrapped work is acceptable. All sculptures should be sturdy and moveable with loose parts and not dangerous for public display. You must provide an adequate pedestal. Artwork that is inappropriate for this family and public event may be prohibited from this exhibit. Exhibit will be turned away if it DOES NOT adhere to these stipulations.
7. All Art should have been created within the last 2 years.
8. This art exhibit is open to those adults 18 and over as of December 31, 2017,

9. Artwork will be entered under these categories:
  1. Oil
  2. Acrylic
  3. Pastel
  4. Watercolor
  5. Mixed Media
  6. Drawing (pen & ink, pencil, charcoal, colored pencil)
  7. Sculpture, 3D (with pedestal if needed)
  
8. All artwork will be handled with care. Submission of artwork for exhibit automatically waives any claim for damage or loss against the LONGMONT ARTISTS' GUILD, OR BOULDER COUNTY FAIR, its members or assigns.
9. Artwork may be moved into different categories at the discretion of the superintendents for the benefit of the exhibit.
10. **SIZE LIMITATIONS:** Artwork is to be no larger than 18" X 24" with frame, Sculpture is to be no larger than 24"x 24" x 24" and weigh no more than 20lbs. Sculpture need to provide their own pedestal.

**EXHIBIT RELEASE:**

- A. Exhibits must be picked up between 5-7:00PM on Monday, August 13, 2018. It is the responsibility of the exhibitor to collect their exhibits or make arrangements to have them picked up.
- B. Exhibits left will be donated to charity.
- C. Ribbons and premium money awarded will be available for pick-up at the Boulder County Fair office through August 31, 2018.
