RULES:

1. The Bucket Calf project is open to all youth, ages four years to eight years of age and not enrolled in any 4-H project other than Cloverbuds. 4-H enrollment is not required.
2. Calves must be born between April 1, 2019 & July 1, 2019.
3. Exhibitor will be allowed to show only **ONE** calf. Exhibitor must own the calf they are showing. Each calf may only be shown once.
4. Superintendents will assign all Bucket Calves to a specific area in the livestock barn.
5. All calves must be tied with neck ropes and halters.
6. All calves must be on the bucket or bottle at Fair time (no nurse cows).
7. All calves must be halter broken.
8. Calves may be of any breed or sex.
9. Fair rules and regulations on stalls, care of livestock and health are to be adhered to.
10. No stall fee is required.
11. No premiums will be given. Winners will receive ribbons only. Each participant will receive a trophy furnished by Mrs. Lee Gould.
12. Enter by Department, Class and Lot. To enter in Bucket Calf, enter Department 133, Class 1, Lot 1.
