

Rules:

- Cornhole Tournament registration fee is \$20.00/team
- The game boards will be 27' apart measured from the front of each board.
- A coin toss will take place prior to the start of the contest. The winner of the coin toss has the option EITHER to throw first or to choose which side their team will throw from.
- Partners will stand across from another on opposite boards.
- Play will start at either board with all 8 bags.
- Stand behind the foul line to throw the bag. The foul line is an imaginary line extending from the front of the boards.
- Each team will play with 4 bags of the same color throughout the match.
- Opponents will alternate throwing the bags until all 8 have tossed.
- This is a family-friendly event. Please refrain from inappropriate language and observe the rules of good sportsmanship at all times.

Scoring:

- First team to 21 points (meeting or exceeding) wins.
- Each bag that goes through the hole is worth 3 points.
- A bag that lands on the board without touching the floor is worth 1 point. The bag needs to be 50% on the board for it to count as a point.
- 0 points are awarded for a bag on the ground. NO bouncing bags onto the board.
- In this game opposing players' frame points cancel one another out. Only those points that do not cancel out apply to the total overall score. Example: Team A scores 5 points in a frame and Team B scores 6 points in the same frame. Team B scores 1 points for that frame.

Length Of Game:

• A 20-minute time limit will also be imposed. If neither team scores 21 points before 20 minutes of game play, the highest score wins the game and will move onto the next round. In case of a tie at the 20-minute time limit, the game goes into sudden death. Boards will be cleared and play order will be determined by a coin toss. The first team to score one point wins the game.
