- No one in my Exhibitor Group’s household is currently exhibiting COVID-19 symptoms, and no one in my Exhibitor Group’s household in the last 14 days has exhibited COVID-19 symptoms, including cough, shortness of breath/difficulty breathing, fever, chills, headache, muscle pain, sore throat, loss of taste or smell, nausea, vomiting, or diarrhea.
- No one in my Exhibitor Group currently has a fever over 100.4 degrees Fahrenheit.
- No one in my Exhibitor Group’s household has (1) tested positive for COVID-19, or (2) if they have tested positive for COVID-19 in the past, they are permitted to discontinue isolation per guidelines from the CDC and/or their treating physician.
- To the best of my knowledge, in the last 14 days no one in my Exhibitor Group has been in close contact (less than 6 feet) with anyone who has tested positive for COVID-19.
- I have no reason to believe that anyone in my Exhibitor Group presently has COVID-19 or has been exposed to COVID-19 in the last 14 days.

COVID-19 WARNING: The novel coronavirus commonly known as COVID-19 and SARS-CoV-2 (the “Virus”) has been declared a worldwide pandemic by the World Health Organization. An inherent risk of exposure to the Virus exists in any public place where people are present, including the fairgrounds and livestock facilities. **The COVID-19 Virus is an extremely contagious disease that can lead to potentially life-threatening illness and even death.** According to the Centers for Disease Control and Prevention (CDC), senior citizens and persons with underlying medical conditions are especially vulnerable. The state of medical knowledge is evolving, but the Virus is believed to spread mainly from person-to-person contact, as between persons who are in close contact with one another (within about 6 feet), through respiratory droplets produced when an infected person coughs, sneezes or talks, and some recent studies have suggested that the Virus may be spread by people who are not showing symptoms. There is also some indication that it may be spread by contact with recently contaminated surfaces and objects. There is no known vaccine for the Virus, and studies are currently underway but not
