### JUDGES PREFER REGULAR GLASS AS OPPOSED TO NON-GLARE GLASS.

### Rules

1. NO DIRTY OR STAINED ARTICLES WILL BE ACCEPTED OR SHOWN.
2. All articles exhibited must be made by hand using any type needle or hook, shuttle, or any other type needle (except those in machine quilting ONLY).
3. Only TWO exhibits in each category of a class will be allowed to each person.
4. YOUTH, 18 years and younger, can use the same list of categories, but their entries will be staged separately and judged separately.
5. SENIOR CITIZENS, 60 years and up, can use the same list of categories but their entries will be staged separately and judged separately.
6. There will be NO EXCEPTIONS to arrival and release times.
7. Minimal machine stitching will be accepted but will not be included in the judging except machine quilting ONLY.
8. All exhibits must be the work of the exhibitor except in the Heirloom Class. Heirloom items will be judged, and eligible for awards, only within that class and not for the overall awards.
9. Incomplete or improperly framed pieces will not be accepted.
10. NO ONE WILL BE ALLOWED IN THE BUILDING DURING JUDGING AND NO ONE WILL BE ALLOWED IN DISPLAY AREA ONCE ACCEPTANCE OF ENTRIES HAS BEGUN.
11. All participants must comply with the Brazoria County Fair Association General Rules and Regulations printed in this catalog, unless otherwise specified.
