All members must be members of (or families' members of) and exhibit in the Brazoria County Fair (i.e., speech & essay, youth horse show, photography, student art, livestock, etc.). All members must have written/signed approval of their parents/legal guardians and their parents/legal guardians must be members of the Brazoria County Fair Association for 2018 and/or 2019.

Applications will be accepted through Friday, March 16, 2018. All applications must be turned into the Fair Office personnel.

YOUTH ADVISORY COUNCIL CODE OF CONDUCT

1. The following guidelines are designed to make your experience at the Brazoria County events satisfying to you and to all others attending. This means that all participants - members, leaders and staff - shall respect the individual rights, safety, and property of others. While you are attending the Brazoria County Fair events, you are representing your high school, your 4-H group and or FFA and the Community.
2. Everyone is expected to attend all of the planned meetings or sessions, workshops and field trips of the event and to be in appropriate dress. When one is involved in putting on an activity for others, appropriate dress means uniform of the Council.
3. The possession and use by members and leaders of alcohol and/or drugs, other than prescribed medication is prohibited at any sponsored events or activities. Members or leaders are not to use tobacco in group meetings. Members are not to use tobacco of any form while in uniform or with others who are in uniform.
4. Obscene and discriminatory language, roughhousing and insubordination will not be tolerated at any time.
5. Members of the Brazoria County Fair Youth Advisory Council will wear the appropriate uniform for all activities that they are in charge of or directing. The uniform will be nice jeans (no holes) or "knee" length shorts with the Fair Shirt. The Fair "T" shirt may be worn at times when one is not on specific duty.
6. Members and adults should demonstrate respect to others.
7. Display of overly affectionate attention between individuals will not be tolerated.
8. Brazoria County Fair Youth Advisory Council is expected to send a quality example to other youth showing at the Fair.
9. One must be willing to perform their Council duties when expected as long as it doesn't interfere with their other fair projects or school activities.

In the event that one should feel that it may become necessary to deviate from the Code, that person agrees to discipline in one or more of the following ways:

1. A warning.
2. Send a member home.
3. Barring that member from future events.
4. Termination of membership from the Youth Advisory Council.
5. Remanding the member to the nearest law enforcement agency and/or the proper authorities.
6. Parents and Fair management will be notified of action taken.

PURPOSE
