- **SET UP: BETWEEN 8am –10pm MONDAY July 15th, MUST be completely set up by 3pm on TUESDAY JULY 16th! Strike down may not begin before 8am SUNDAY, JULY 21st. **DO NOT PLAN ON SETTING UP AFTER TUESDAY AT 3 OR LEAVING BEFORE SUNDAY! NO REFUNDS****
- Application **MUST** include a photo (unless you were here before and have not changed trailer)
- No equipment will be provided. Booth assignments are out-of-doors and uncovered. You must bring your own tables, electrical cords, tents, electrical adapters, etc.
- Application and additional electrical fees (if any) must be included or no booth assignment will be made.
- Send booth application to: Cass County Fair, %City Hall, 203 Paul Street, Pleasant Hill, MO 64080. Make sure your application fee is enclosed, and the check made out to the Cass County Fair.
- **Gray water must be contained.** A dumping station will be available. Failure to comply will result in immediate dismissal from the Cass County Fair. No exceptions!
- Electricity is very limited. Please do not request EXTRA unless you need it!
