- **Valley Fire response.** Initially called upon to open as an evacuation center, we transformed overnight into a two-week shelter operation providing somewhere to stay, hot meals, medical and social services, and animal and pet care for over 1,000 evacuees, including receiving and distributing semi-loads worth of donated items to those affected.
