~ENTRIES OPEN JULY 15 and close when the trial is full

~Entries will be processed in order of postmark date. Any entries received after the trial is full will go on a waiting list in order of postmark date.

~The Black Hills Cattledog Challenge will be limited to 50 dogs: 30 open class, 10 nursery class and 10 Novice/Intermediate class. If a class is not filled by the deadline date, then the limit for another class will be adjusted and entries from the waiting list will be added. ~Limited to 2 dogs/handler/class

~Open and Nursery classes are USBCHA sanctioned. Novice/Intermediate classes are not. The novice and Intermediate class will be run congruent but scored separately according to the class.

~Intermediate class is for Intermediate Handlers Only.

~Handlers meeting will begin at 8:00 am MST each day with the trial beginning at 8:30 am MST.

~Please be considerate and clean up after your dog!

~Health Certificates for dogs are required to enter the fairgrounds

~The parking/fair pass is good for both days and gets one vehicle with 4 occupants into the fairgrounds. Parking will be next to the event center inside the fairgrounds.

LODGING

USBCHA Membership Information

***USBCHA Membership is NOT required to enter this trial.** However, if you would like to receive points towards qualifying, you must become a member. See below:

There are three categories of membership in the USBCHA: Life, General or Associate. You must be a current paid member in one of those categories before you go to the post to receive qualifying points from that trial. Membership is dated based on postmark of check, date of PayPal payment or verification by a director or officer of USBCHA that payment was made in person prior to going to the post. You may join as an associate member prior to running in a USBCHA Open or Nursery trial and receive any points earned as a member. You will become a general member once you have run in USBCHA nursery or open class. General and Associate memberships are renewed annually and run from Jan 1 thru Dec 31. All annual memberships expire Dec 31 regardless of when the membership was paid for that year. Annual dues are \$25.00.
