- ❖ Commercial Booths may set up on Wednesday August 28, beginning at 10am- 4PM & Thursday from 10am- 4pm. All booths MUST be ready by 5pm, Thursday. We do not provide tables or chairs to Fairground vendors.
- ❖ Nothing may be sold, given away, or otherwise disposed of by an exhibitor without approval. Booths must be kept attractive and fit in space designated on the application.
- ❖ We must have booths open during all hours of operation. Please make sure your booth is adequately staffed for the weekend.

- ❖ Assembly Hall Booths share room with Hypnosis show. This show brings in traffic and generates noise. No sound systems or broadcasting devices of any kind may be used without the approval of the Fair Management.
- ❖ No outside food/ drinks allowed unless it's been approved with Fair Management. We have concessions & multiple food trucks open during the fair.
- ❖ All exhibitors will be required to have an exhibitor pass or pay admission. Each exhibitor may be issued up to 4 passes. Additional passes may be purchased for \$10.00 each.
- ❖ Refunds & Cancellations: No refunds will be given after application is received. If your payment is not received with application, your application will not be processed. If you cancel, your booth will no longer be available. Our goal is to have every spot we have full.

Security personnel are on duty at all hours during the Fair for your protection and safety. The Central Texas State Fair/Bell County Expo Center will not be liable for loss or damage caused by fire, theft, or vandalism.
