Reservation Form: The Fair Office will require this form filled out fully, along with full payment, to be mailed back to the address listed at the bottom of this form to reserve your camping space.

Payments: Camping reservations will not be held until this form and full payment has been received in the CWSF office. If any checks are returned, you will be notified immediately, and additional charges may apply. You will have two weeks after initial contact from the CWSF office to make payment. After the two weeks, your space will be given to the next customer. Additional charges may apply for credit card purchases.

Cancellations: If you need to cancel your stay at any time, please notify the Fair Office immediately. Cancellations made prior to June 1st will receive their full payment back. Cancellations made after June 1st are non-refundable.

Campground Rules: Per City Ordinance, we ask that all loud activities stop at 10:00pm. Failure to comply with this ordinance could result in your removal from the campgrounds without a refund. Generators, fireworks, campfires, grills, pets, and alcohol are **NOT** permitted on the campground at any time. Any camper/vehicle parked outside their assigned campsite will be towed at the expense of the owner. Persons under 18 years of age must be accompanied by a parent or guardian to camp overnight. It shall be at the authority of the fairgrounds personnel, or their representatives, to remove from the grounds any or all members of a group whose behavior, at any time, conflicts with County or State laws; becomes detrimental to the health and safety of the group or other campers/fair-goers; or becomes so unruly as to affect the reasonable enjoyment of the grounds by others. If anyone in your site is asked to leave by CWSF Personnel or the Marshfield Police Department, there will be no refunds under any circumstances. Camper's vehicles are not permitted to park outside of their assigned site, and may be towed at the owner's expense.

Check-In: Check-in can be at any time on the first day you have listed on your camping form, unless stated by the CWSF office. If there is a no show / no call, your spot may be forfeited with no refund. If for some reason you cannot make it to the campgrounds on the first day you have listed on your camping form, please call the Fair Office before 5:00 PM. Upon arriving you will be required to post your camping permit, which you will receive in your packet via mail. This permit must be placed in a camper window and must be visible at all times. Campsites are assigned according to power availability and length of reservation requested.

Electrical: Any campers plugged into the wrong outlets will be contact by CWSF personnel. If CWSF personnel cannot get a hold of you in a timely manner, you will be unplugged from the outlet. The CWSF cannot be held responsible for any costs that may be incurred from unplugging campers.

Dump Station: Upon check-out you may wish to use a Sanitary Dump Station. The dump station will not be available during the Fair. The Dump Station is located on the grounds, next to the Round Barn, by the Fair Office. There is a City fee of \$5.00 per use for this service. All payments for the dump station can be made out to the CWSF and placed in the drop box located next to the Dump Station.

Showers / Bathrooms: Campers are welcome to use the showers and bathrooms located inside the Lang 4-H building near the campgrounds during their stay. These facilities will be available 24 hours a day during the Fair. If you notice, at any time, that these facilities need to be re-stocked, cleaned, or need any maintenance, please contact the Fair Office during Fair days between 8:00 AM – 8:00 PM.

Internet Access: WiFi access codes can be purchased at the Fair Office anytime during office hours. Office hours will be posted on the office door. Each pass is only good for one device. Daily passes are \$2.00 each. Weekly (7 day) passes are \$10.00 each. Additional charges may apply for credit card purchases.

Garbage: There are dumpsters and garbage cans available throughout the grounds for your garbage needs. We ask that you help us keep our grounds clean and looking nice at all times.
