The Board of Directors of the Chowchilla Madera County Fair and Event Center are pleased to announce that applications are being accepted for the **WEE MISS MADERA COUNTY PAGEANT**. The **WEE MISS MADERA COUNTY PAGEANT** is for females only. A maximum of eight (8) contestants will be allowed.

This is not a beauty pageant, Wee Miss Madera County is judged on poise, personality, behavior and appearance.

**Applications must be submitted to the Chowchilla Madera County Fairgrounds Office by 5:00 p.m. on Monday, April 1, 2019. The Pageant will be held on Thursday, May 16, 2019, at 7:00 p.m. in the Little Theater at the Chowchilla Madera County Fairgrounds. The Pageant will be held as part of the Chowchilla Madera County Fair.**

The Wee Miss Madera County pageant winner will be selected by an impartial panel of judges. Contestants will be evaluated on the categories listed below. The pageant show changes each year and contestants may be required to participate in an opening dance number or other event activity. The Coordinator reserves the right to make changes as necessary.

The contestants will be evaluated in the following categories:

- Poise
- Personality
- Behavior
- Appearance
- Points will be awarded for sale of raffle tickets and Partnerships

Pageant winners will receive the following:

Wee Miss Madera County	\$100.00, a crown, sash and trophy
Most Sold Raffle Tickets	\$100.00 Award
Most Sold Partnerships	\$100.00 Award

**The Wee Miss Madera County Pageant winner will be obligated to participate in the Chowchilla Spring Festival parade on Saturday, May 18th.**

Winners of the Wee Miss Madera County Pageant will be required to be present daily at the Chowchilla Madera County Fair, and other community events that may be scheduled throughout the year in Madera County. All appearances will be approved by the Miss Madera County coordinator.

## APPLICATION REQUIREMENTS

- A completed Wee Miss Madera County Pageant application must be received in the Chowchilla Madera County Fairgrounds office by 5:00 p.m. on **Monday April 1, 2019**.
- Contestants must be between the ages of 5 and 7 years as determined by their age on May 16, 2019. **A copy of the applicant's birth certificate or official school record with a birth date must accompany application.**
- Contestants must have resided in Madera County for at least six (6) months prior to the date of the pageant (proof of residence may be required).
- No contestant shall have won a prior Wee Miss Madera County Pageant, nor have been a professional model, appeared professionally on TV, radio or in print of any form for professional compensation. Having won another amateur contest for awards does not exclude a contestant from participating.
- Specific dress attire will be discussed during the orientation sessions and further changes may be added. In general, no makeup of any kind will be allowed, no panty hose or leotards will be allowed, no sandals, open toe shoes, flip-flops, or heels taller than 1-inch high will be allowed, no spaghetti strap or strapless dresses will be allowed, straps must be a minimum of 1-½" wide, and dresses must not be shorter than knee length.
- **To qualify to be a contestant, all applicants will be required to sell a minimum of \$250.00 in Royalty Raffle tickets or Fair Partnerships. If the applicant does not sell the minimum by the deadline, that applicant will no longer be eligible to be a contestant. No refunds will be issued for raffle tickets or Partnerships. Proceeds will be used toward pageant awards and the Fair.**
- The 2019 pageant schedule will be handed out at the meeting on **Thursday, April 4, 2019**.
