Dear Junior Independent Exhibitor;

Enclosed are the official forms for Independent Exhibitors to complete. Please read all the information carefully. All records are required to be completed and maintained on your project. You must submit these records to the Livestock Office upon your arrival at the fairgrounds on Monday, May 11, 2020.

**This form is only a declaration of your intent to exhibit.
You are still required to submit your entries online at www.chowchillafair.org
between March 1 - April 17, 2020.**

Please note the **Independent Exhibitor Declaration of Intent to Exhibit** deadline dates are different than **Pre-Weigh In** date for Market Steers.

If you are exhibiting a MARKET STEER your animal must physically attend the Pre-Weigh In on Saturday, January 18, 2020, at Producer's Livestock in Madera, CA. Your Market Steer must be weighed and tagged between the hours of 10:00am – 12:00pm.

The 2020 Chowchilla-Madera County Fair deadlines for submitting your Independent Exhibitor Declaration of Intent to Exhibit form (See Page 3) are as follows:

You must complete the Independent Exhibitor Declaration of Intent to Exhibit form on page 3 and return it to the Chowchilla Fair office, along with the photographs of your animal and all required documents no later than the date specified above. You must complete and retain pages 4-7 for your record keeping.

REQUIRED DOCUMENTS: Junior Independent Exhibitors entering a market and/or breeding animal must provide the fair office with the following, by the deadline date specified above;

- 2 pictures of your animal(s) (a close-up side view and front view of the animal)
- Proof of ownership.
- Permanent tag and/or tattoo information by ownership deadline as outlined in State Rules
- Letter from parent/guardian stating who will be supervising the exhibitor at all times.
- Project records (pages 4-7) must be submitted to the Livestock Office staff when the exhibitor arrives at the fairgrounds, Monday, May 11, 2020.
- Read Livestock Rules in the Exhibitor Handbook for appropriate dress code
- **Independent Exhibitors must provide insurance coverage as required by the Fair (Independent Exhibitors can purchase insurance from the Fair for \$35.00).**
