OPTION I

You have the right to request Driving Safety Course. You will lose that right if you do not provide written notice to the Court on or before your appearance date. Only one (1) charge may be dismissed by taking a DRIVER SAFETY COURSE (DSC) OR MOTORCYCLE OPERATOR TRAINING COURSE (MOTC). By signing the reply form YOU CERTIFY BELOW THAT YOU:

- A) have not taken a DSC or MOTC within the past twelve (12) months preceding the date of offense and are not in the process at this time; and
- **B**) were not speeding 25 miles per hour or more over the posted speed limit; and
- C) were not cited in a construction zone with workers present; and
- **D**) do not hold a Commercial Driver's License (CDL).

I hereby wish to waive my right to a trial by jury, enter a plea of () Guilty () No Contest and Request to take a DSC or MOTC. I understand that this plea enters a guilty judgment and this judgment will be removed and no conviction will appear on my record upon submitting proof of completion of the required DSC or MOTC and a certified copy of my driving record as maintained by the Texas Department of Public Safety.

DO NOT TAKE a driving safety course UNTIL THE COURT CONTACTS YOU BY MAIL. Today, you agree to include the following items with this signed form to the court:

- 1) a copy of your valid Texas driver's license or active military ID;
- 2) a copy of the proof of insurance with your name listed on the insurance card; and
- 3) a Cashier's Check or Money Order in the amount of \$144.00 or \$169.00 for School Zone Offenses.

OPTION II

I hereby enter a plea of () Guilty () No Contest and waive appearance for trial and enclose a Cashier's Check or Money Order for the amount of the fine(s) listed. A plea of Nolo Contendere means that you do not contest the State's charge(s) against you; the fine is the same as a guilty plea. Please return a copy of your citation and this signed form with your remittance for proper credit.

I hereby enter a plea of **Not Guilty** and understand that I will be notified of my trial date. I understand that I have the right to be represented at trial by an attorney and a trial by Jury.

A child and parent required to appear before the court have an obligation to provide the court in writing with the current address and residence of the child. The obligation does not end when the child reaches age 17. On or before the seventh day after the date the child or parent changes residence, the child or parent shall notify the court of the current address in the manner directed by the court. A violation of this subsection may result in arrest and is a Class C misdemeanor. The obligation to provide notice terminates on discharge and satisfaction of the judgment or final disposition not requiring a finding of guilt.

If an appellate court accepts an appeal for a trial de novo, the child and parent shall provide the notice to the appellate court.
