NOTICE OF PUBLIC HEARING ON TAX INCREASE

A tax rate of .3511 per \$100 valuation has been proposed by the governing body of CITY OF GONZALES.

The no-new-revenue tax rate is the tax rate for the 2020 tax year that will raise the same amount of property tax revenue for CITY OF GONZALES from the same properties in both the 2019 tax year and the 2020 tax year.

The voter-approval tax rate is the highest tax rate that CITY OF GONZALES may adopt without holding an election to seek voter approval of the rate, unless the de minimis rate for CITY OF GONZALES exceeds the voter-approval tax rate for CITY OF GONZALES.

The de minimis rate is the rate equal to the sum of the no-new-revenue maintenance and operations rate for CITY OF GONZALES, the rate that will raise \$500,000, and the current debt rate for CITY OF GONZALES.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that CITY OF GONZALES is proposing to increase property taxes for the 2020 tax year.

A public hearing on the proposed tax rate will be held on September 03, 2020 at 6:00 PM at Gonzales Municipal Building 820 N Saint Joseph Gonzales Texas.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, CITY OF GONZALES is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the of CITY OF GONZALES at their offices or by attending the public meeting mentioned above.

The 86th Texas Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.
