HEARING OF RESIDENTS

Pursuant to Section 551.007(c) of the Texas Government Code, the total time allotted for Hearing of Residents is limited to thirty (30) minutes per meeting, but in no event shall one (1) speaker exceed three (3) minutes unless otherwise allowed by the Presiding Officer. Members of the public desiring to provide public comment on matters scheduled for a public hearing will be allowed to speak only once either during Hearing of Residents portion or during the public hearing

All remarks shall be addressed to the Board as a body, and not to any individual member thereof.

Discussion by the Board of any item not on the agenda shall be limited to statements of specific factual information given in response to any inquiry, a recitation of existing policy in response to an inquiry, and/or a proposal to place the item on a future agenda. The presiding officer, during the Hearing of Residents portion of the agenda, will call on those persons who have signed up to speak in the order they have registered.


