



**Trash Collection Regulations:** *Failure to comply with these rules is considered a city ordinance violation and may result in a complaint filed against you through municipal court.*

- ✓ You must bag all garbage that is placed in your polycart (blue trash container)
  - (including, but not limited to, boxes of any kind)
- ✓ You may not fill the polycart to a capacity which prevents the lid from complete closure.
- ✓ The collection cart and any items not collected shall be removed from curbside on the day in which the collection is scheduled to occur. Collection carts, bulky waste and other refuse containers should be screened from public view except during the hours when placed for collection.

***Yard Waste Regulations: Failure to comply with these rules is considered a city ordinance violation and may result in a complaint filed against you through municipal court.***

- ✓ You may not place any limbs or yard waste at the curb any sooner than the weekend prior to your scheduled pickup date (see below for scheduled pick-up date)
- ✓ City will not remove yard waste from businesses. Therefore, you must remove at your own expense
- ✓ All limbs and yard waste must be placed within your property lines, as close to the curb as possible
- ✓ All brush piles must be no larger than 5 feet tall, by 5 feet wide, by 10 feet long or 10 cubic yards.
  - \_\_\_\_\_(length in ft) x \_\_\_\_\_(width in ft) x \_\_\_\_\_(height in ft) ÷ 27 = Less or equal to 10 cubic yards
- ✓ No limbs may be longer than 8 feet in length
- ✓ All grass clippings, plants, leaf litter, garden waste, and small limbs must be placed in bag(s)
- ✓ City will not remove yard waste from any property without utilities

\*\*\* Recycle station to dispose of yard waste is located at 501 Fifth Street.  
Hours of Operation are: Saturdays 9 am to 5pm.

**Pick-up dates:**

- Area # 1 Northwest area (1<sup>st</sup> full week of the month)- North of Washington Ave and West of LaSalle
- Area # 2 Northeast area (2<sup>nd</sup> full week of the month)- North of Washington Ave and East of LaSalle
- Area #3 Southeast area (3<sup>rd</sup> full week of the month)- South of Washington Ave and East of LaSalle
- Area #4 Southwest area (4<sup>th</sup> full week of the month)- South of Washington Ave and West of LaSalle
