ENTRY FEE:

\$25.00 DUE April 6, 2020 WHEN YOU WEIGH-IN YOUR ANIMAL. CASH OR CHECK MADE PAYABLE TO THE “CLAY COUNTY FAIR ASSOCIATION”. Exhibitor’s animals not qualifying do not have to pay.

ELIGIBILITY:

1. All exhibitors must have completed an application and meet the entry/drawing rules to be eligible for participation.
2. Exhibitors must be 10 years old by September 1, 2019.
3. Exhibitors must reside in Clay County or attend a Clay County School. High School graduates are ineligible. Exhibitors must be in good standing in school.
4. Exhibitors must be a bonafide member of a Clay County 4-H Club or FFA Chapter and must have met all the requirements of 4-H or FFA and be member in good standing. **The Fair cross-references the list of applicants who have submitted applications to exhibit steer. 4-H or FFA members must have been a verified member in good standing for 1 year to earn eligibility to show a steer in the Clay County Fair. Individuals who are not verified members in good standing or those whom have not been a member of 4-H or FFA for 1 complete year prior to the show are not eligible to exhibit.** Exhibitors not in good standing will not be allowed to participate. 4-H Members at Large do not qualify.

GENERAL RULES:

1. Exhibitors and FFA Chapters may only show and sell one market animal.
2. Each 4-H and FFA participant must have the ability to control their animal independently or will be disqualified. Each participant must assume all liability in case of injury or damage to, or caused by exhibitor's animal, relieving Clay County Fair Association, Inc. from all liability.
3. Exhibitors must wear official 4-H or FFA attire at the show, and sale. No caps or cowboy hats are to be worn during the show. **FAILURE TO ADHERE TO DRESS CODES DETERMINED BY THE STEER SUPERINTENDENT WILL RESULT IN NOT SHOWING AND/OR SELLING THE ANIMAL.**
4. In the event of a legitimate medical or family emergency, (as determined by the livestock directors) a market swine or market steer may be shown in competition for its placing in class by another swine or steer participant in the fair. The animal will compete in its
5. class for placement in class only and will not be allowed for competition for the showmanship or fitting/grooming categories. Exhibitor must have their animal properly trained so that it may be managed and led into the show ring by the **EXHIBITOR**. A non-controllable animal will be disqualified.
6. Any tampering with animals entered during the Fair, (such as filling with a foreign substance, etc.) is prohibited. The use of tranquilizers on show animals or the possession of same after arrival at the Fair will be construed as a form of tampering. The Livestock Committee and authorized agents shall have the right to handle and examine animals at any time during the Fair. If evidence of tampering is found, the animal shall be removed from the Fairgrounds and disqualified. If after the sale, all proceeds will be forfeited and the exhibitor is prohibited from showing the following year.

7. **GIFTS: Mandatory for livestock swine / steer participants:** All livestock participants are required to provide one (1) buyer gift per participant to include a thank you card for the main buyer of their animal on auction night. (This thank you card does not take the place of the buyer thank you letter due after the fair; see page 8 of the rules “After the Fair” #1 for clarification). The gift must be checked in at the sale arena prior to the sale. (a table will be setup at the arena for checking in the gifts)
Participants must provide a 3x5 card with the participants name, sale # and animal tag #.
Gift prices range from \$25.00 - \$75.00.

Gift ideas:

- a. Basket filled with local products
- b. Fruit basket
- c. Gift cards with a thank you card:
 1. Restaurant
 2. Store
 3. Visa card (to be used anywhere)

Participants not providing gifts for their buyers the night of the sale, will be penalized a \$50.00 fee from their sale check.

STEER ORIGIN:

1. May be purchased anywhere.
2. Must be polled or dehorned thirty (30) days before the show; however, scurs and secondary growth of horns two (2) inches or less will be accepted. Final acceptance will be by the Livestock Committee.
3. An official tag number that clearly identifies the animal will be assigned on December 1, 2019 at the mandatory weigh-in. A photo will be taken at the time of weigh-in.

MANDATORY WEIGHT-IN:

Animal must be of beef type and not less than 75% BEEF BREEDING.

This will be determined by the Steer Superintendent.

Mandatory Weigh-In & December 1, 2019 @ 2:00 PM

1. All steers must be unloaded and weighed on foot, on certified scales at the Clay County Fairgrounds on December 1, 2019 at 2:00 PM in the presence of the Steer Superintendent/Fair Livestock Director. Steers must weigh a minimum of 700 pounds to be qualified and must be a quality animal. Parents may not assist in weighing their own child's steer.
2. This weigh-in also qualifies all exhibitors to participate in the Weight Gain Contest.
3. Participants are required to write letters to three (3) new potential buyers and include unsealed, addressed, stamped envelopes. The Livestock Buyer Director will be responsible for mailing the letters and must receive them by December 1, 2019.

FINAL WEIGH-IN:

Exhibitors must turn in a completed Market Livestock Record Book (to that point of the project).

\$25.00 DUE April 6, 2020 WHEN YOU WEIGH-IN YOUR ANIMAL. CASH OR CHECK MADE PAYABLE TO THE "CLAY COUNTY FAIR ASSOCIATION".

Exhibitor's animals not qualifying do not have to pay.

LIABILITY:

The exhibitor assumes all liability in the case of death, or injury to his/her animal until the close of the Fair. No show official or member of the Fair Association may be held liable for the loss of any animal or damage caused by exhibitor's animal.

SALE:

1. **All steers qualifying will participate in the sale and must go to slaughter.**
2. Maximum steer weight is 1275 pounds. Any steer weighing over 1275 lbs. will be sold as weighing 1275 lbs.
3. It is the responsibility of the exhibitor to find a buyer for their animal. The Clay County Fair Association is not responsible for providing buyers. **Exhibitors should not solicit fair vendors as potential buyers.** No buyer gifts from exhibitors are allowed at the auction.
4. Three percent (3%) will be deducted from the total sale of the animal. This will be used to bring any sale animal up to minimum sale price or to buy a sale animal that has received no bids. The minimum sale price will be determined prior to the sale by the Clay County Agricultural Fair Livestock Committee. If the expense does not exceed the 3% income for that year, the remaining 3% balance will remain in the livestock account. Excess money will be put into a fund to be used for the same purposes in future Clay County Agricultural Fairs.

SHOW & JUDGING:

1. All steers must gain a minimum of 224 pounds total following the weigh-in, and must weigh at least 924 pounds at the Fair weigh-in on April 6, 2020. Steers not meeting the weight or grading requirements will be disqualified from the show, showmanship, fitting & grooming & sale. Owners of these steers may participate in record book competition only.
2. Steers may be divided into separate weight divisions for the show depending on the number of entries.
3. Show and Sale Grooming area before and during the show will be open to exhibitors working on animals. Juniors may have one (1) parent to provide **VERBAL HELP ONLY.** Seniors may not have any help. Advisors and 4-H leaders may enter, (for safety reasons only).
4. All exhibitors will abide by State of Florida Livestock Health Regulations and Requirements listed on the Clay County Fair website. **A health certificate is required to accompany the animal to the fairgrounds. Must be issued by a vet.**

5. Junior, Intermediate and Senior exhibitors may participate in Showmanship competition. The fitting and grooming contest is open to Intermediate and Senior exhibitors only. FFA Chapter steers will compete against each other and all clipping & grooming must be done at the Fair.
6. Juniors are 11 years of age and under as of September 1, 2019. Intermediates are 12-13 years of ages of September 1, 2019. Seniors are 14-18 years of age as of September 1, 2019.
7. Sale receipts will be handled by the Clay County Fair office.

GENERAL BARN RULES:

1. All exhibitors must use bedding provided by the Clay County Fair.
2. Feed and water pails must be provided by the exhibitor. **No animals are to be moved through the barn for any reason during fair hours unless authorized and accompanied by the Steer Superintendent or designee.**
3. All exhibitors of livestock will be required to maintain their stall, walkway, and space in a clean and sanitary condition, and to remove any filth or litter and place it in a designated pick-up area. The sanitation department of the Fair will remove refuse from designated pick-up areas only. Non-compliance of this rule will result in hiring of personnel to clean exhibitor's area, and labor costs will be deducted from exhibitor's proceeds.
4. Each steer must be securely tied at all times with at least a 3/8 inch rope halter and neck rope. All steers will have a neck rope on at all times while tied at the Fair. The neck rope and lead rope shall be no more than 18" from knot to animal at any one time that they are tied. Failure to do so could result in a \$5.00 fine deducted from sale price of steer. (This is to keep animals from getting tangled in their ropes or their neighbor's ropes due to not keeping ropes tied properly). Same rule for untied, loose animals.
5. Exhibitors not properly feeding, caring for and/or managing their steers will be charged
6. \$25.00 and forfeit right to all awarded premiums. Further violation will result in removal of animal and disqualification.
7. Each exhibitor is responsible for his animal arriving on time at the place designated by show officials.
Any questions or problems will be handled in the order of the Steer Superintendent, or the Livestock Directors.
8. Awards will be presented at the Barn, Saturday, April 11, 2020 @ 2:00 PM.

AFTER THE FAIR:

1. The exhibitor must turn in their completed **Record Book** to the **Clay County Agricultural Fair Office** no later than **Friday, May 1, 2020**. Any Record Books received after this date or not complete will result in the 4-H/FFA Exhibitor being fined a \$100.00 penalty from their final check that will be put into the 3% Livestock fund. The exhibitor will sign in at the fair office acknowledging their book is at the fair office. After all books are received, the swine and steer superintendents will turn all 4-H books over to the 4-H office which will complete the fair project. FFA books are returned to each FFA participant. **Write thank you letters to your buyer(s) and turn them in with your project book in an addressed, stamped, sealed envelope. The Fair Association will mail the letters.** An exhibitor who met all requirements on time and meet all current Clay County Fair

requirements will be eligible for the same animal project. (Participant can have the option to switch programs one time only)

2. **BUYER PLAQUES:** Plaques must be picked up from the Fair Office after May 18, 2020 by the exhibitor and delivered to their buyer. An email will be sent out to notify you that the Buyer Plaques are ready for pick-up. Checks will not be issued until proof is returned that the buyer received the plaque and after June 18th. Forms for a signature from the buyer stating they received the plaque will be provided by the Fair office.
3. **Checks: Checks: Checks will be issued after June 22, 2020 providing "ALL" Livestock Buyer payments have been received. If anyone of your buyers do not pay their bid amount it will deducted from your check.** An email will be sent out to notify you that the checks are ready for pick-up. No checks will be disbursed until all requirements have been completed. Checks will only be given to exhibitors with proper identification, such as photo ID, Fair ID Badge or 4-H/FFA card. Parents listed on application may pick up checks with proper ID.******The steer project requires that all checks must be deposited within 30 days of receipt. If a check is not deposited within this timeframe the checks will be voided and your slot in the next year's show & sale will be jeopardized.**

PREMIUMS & AWARDS:

The Modified Danish System of Judging will be used.

FITTING & GROOMING CONTEST:

Open to Intermediates and Seniors showing steers. FFA Chapter steers will compete against each other. All grooming will be done at the fair under supervision. Participants will be judged on how their animals are fitted and groomed for show purposes. Adults helping in Senior Fitting & Grooming will cause the animal to be disqualified. Fitting & Grooming is to be done by the exhibitor only.
