The Colorado State Fair will strictly enforce on grounds parking this year. The purpose of driving on the Colorado State Fairgrounds should be restricted for business purposes only. Driving on the fairgrounds is not intended for personal reasons. Violators will be towed at owner's expense.

- No vehicle will be allowed onto the fairgrounds without the proper permit.
- All parking permits admit vehicle only.
- All parking permits do not include Fair gate admission. **All occupants in vehicles must show or have a valid Colorado State Fair credential or pay Fair gate admission to enter the fairgrounds.**
- Vehicle will only be allowed to enter through the gate assigned on permit.
- Any alteration to any parking and gate permit by unauthorized personnel will result in disqualification.
- Do not block fire lane.
- This is a revocable privilege. Space is not guaranteed.
- Improperly parked vehicles or date and time limit violations will cause vehicle to be towed at owner's expense.
- Credential holder is responsible for proper use of all credentials.
- The Colorado State Fair is not responsible for any theft or damage to any vehicles or contents left in vehicles or trailers.
- The credential holder so assumes all risk of personal injury & loss or damage to personal property due to any cause.
- Vendors will only be allowed to drive and enter through Gate 6 for load/unloading with an enforced time limit.
- Colorado State Fair staff is not responsible for locating owners of improperly parked or time limited vehicles. **VEHICLES WILL BE TOWED AT OWNER'S EXPENSE.**
