LIVESTOCK PASS, PARKING AND ADMISSION INFORMATION

Special Gate and Parking Pass information for Livestock exhibitors! Passes should be purchased with Colorado State Fair Livestock Entries. No passes will be mailed out to exhibitors. Exhibitors can pick up their passes in the Livestock Office when they arrive and check in.

Beginning Friday, August 23rd, everyone who walks through Gate 4 <u>MUST</u> have either a wristband or general admission ticket. Daily tickets may be purchased at Gates #3 (Carnival Gate), #5 (Prairie Gate) and #9 (Beulah Gate). The Colorado State Fair will be offering Special Discount Days – those will be posted at coloradostatefair.com.

All vehicles must enter through Gate 4. All vehicles must stop at the Vet Check-In for animal inspection and Health Paper verification. Exhibitors will be issued a 30-minute loading/unloading permit which will allow them onto the Fairgrounds. Any vehicle abusing the 30-minute time limitation will be towed at owner's expense.

- 4H/FFA Livestock Exhibitor Wristbands are for exhibitor only 1 will be issued per exhibitor additional 4H/FFA wristbands ordered under an exhibitor's name will be charged the \$35.00 for the all-age Livestock Exhibitor band.
- Note that Generator and Refrigerated Cooler Permits are issued <u>ONLY to Beef Exhibitors</u>. Exhibitors who are not exhibiting beef and order one of these permits will not receive refunds.
- All-age Livestock Exhibitor Wristbands should be purchased for the parents/grandparents/friends of 4H/FFA exhibitors unless they elect to purchase daily tickets.
- All trailers must be parked at the designated off-premises parking location (free). No trailers are allowed in the parking lot outside Gate 4 or in the South Lot. Trailer parking is located at the intersection of Pueblo Boulevard and Lake Avenue. This is a free lot for trailer with 24-hour security. No sleeping in trailers in the trailer lot.
- All vehicles parked outside Gate 4 must park within lines. All vehicles parked in the South Lot must be parked in an orderly fashion.
- ➤ Gate 4 parking passes **do not** allow for parking in the official lot behind the Livestock Pavilion. No exhibitor parking allowed behind the Sheep and Swine Barn.
- Vehicles not parked in the correct parking space or lot areas will be towed at owner's expense. No exceptions! Vehicles not possessing the correct or expired permits will be towed at owner's expense. No exceptions.
