Please submit your applications to the address below. Payment must accompany application. Please make checks payable to “**Friends of Conroe**”.

Attach to the completed application (applications missing the following information will be disqualified)

- A brief Bio or Artist Statement.
- 3 non-returnable photos of your original art and 1 complete booth/tent shot.
- Photos must be no smaller than 4x6 and be of current work. No reference to website.
- Photos must be labeled with artist name, medium, date of work, and title of piece.
- Payment (Applications not accepted will be fully refunded)

The Cajun Catfish Fine Art Festival is open to any artist living in the greater South Central Texas Community. The fine art event area will take place in a shaded/partial sun blacktop parking lot, within the area of the music festival. The Conroe Cajun Catfish Festival is a premier outdoor fall event, sponsored by The Friends of Conroe, who are committed to providing an outstanding family event while creating a positive selling atmosphere for the exhibitors. Now in its 30th year, the Festival continues to bring in over 30,000 people during the three days.

### Artist Information

- Festival hours of operation – Friday 6pm-12am; Saturday 11am-12am; Sunday 12pm-6pm. Exhibitor should be available during those times, leaving early is at your own risk.
- Each tent space will be 10x10, unless you specify a 10x20. Electricity is provided at an additional cost. Artwork and display walls must be contained within this space.
- Each artist is required to be in a tented a space. No exceptions.
- Artists displaying outside of their 10x10 or 10x20 area will be asked to remove their items as planned accordingly.
- Artists are selected into the show by a panel of qualified judges.
- This event is non-refundable. No rain date is available.
- No pets allowed.
- Each artist is responsible for collecting and reporting Texas sales tax for sales of the show.
- Artists not accepted into the show will be refunded.
- Booth placement and setup/breakdown schedules will be mailed 2 to 3 weeks before the show.

Policies: The following policies and regulations have been established for the Cajun Catfish Fine Art Festival to ensure quality and integrity of the process, presentation and patron experience.

- All Artist represented on the entry form must personally attend their exhibit and must be present during the entire scheduled days and hours specified.
- Works exhibited must be consistent with the images submitted.
- All work submitted and exhibited must be original, hand-crafted work produced by the artist and may not be the result of work by any other person other than the artist applying. No commercial kits, molds, patterns, plans, prefabricated forms or any other commercial methods are allowed.
- Artists may apply in multiple categories.

- T-shirts are not allowed to be sold.
- Artists are responsible for proper insurance and protection of work and set-up. The Festival is not responsible for damage to work or set-up due to weather or unrelated incidents. Additionally – not responsible for theft- Overnight security is provided by the festival from 12am to 9am Saturday and 12am-9am Sunday- This is only roaming security.
- Artists retain 100% of their sales and are responsible for the collection and reporting of all applicable sales tax. Texas state tax is 8.25%
- All artists are expected to comply with all regulations and respect artistry standards.
- The show discourages any person from applying if they are not inclined to misrepresent both their craft and the industry.
