<u>Approval of Agenda</u> - **Motion** by Storlie and seconded by Deplazes to approve the agenda with additions. Motion carried unanimously.

<u>Approval of Minutes</u> – **Motion** by Barrett and seconded by Storlie to approve the minutes from the June 4th meeting. Motion carried unanimously.

Motion by Muller and seconded by Malecha to put a new road to DCHV subject to their approval. Motion carried unanimously.

Discussion was held on the blacktop road, Mopar would like to use this for their event for burn outs.

<u>Old Business</u>: Henry would like approval for a mentor hunt on October 27th, 2018. **Motion** by Malecha and seconded by Casura to approve this. Motion carried unanimously.

Discussion was held on the rain Insurance for this year's fair. Motion by Muller and seconded by Deplazes to go with ¼ inch for the four days of the fair. The cost of this is \$6080.00. Motion carried unanimously.

Discussion on the Cannon Falls parade. Barrett will set it up.

Motion by Muller to adjourn and seconded by Henry. Meeting was adjourned at 8:50 p.m.
