3) ATTENDANCE

- In person meetings are preferred but not always workable.

MONTHLY FAIR BOARD MEETINGS

- Fair Board is to meet every month
- Committee Chair can decide if committee needs to meet every month
- 3 or more Fair Board Directors – open meeting law applies
- Post Agenda 24 hours ahead, take minutes, and comply
- Have a set agenda to post each month

CALENDAR

- Schedule Fair Board meeting December 17, 2020 and January 21, 2020 (no NWSS)

BUDGET

- Budget was submitted in June based on 2019 for 2020
- Review at the committee level
- Have a strong sense that we need to work on filling the gap between expenses and revenue
- What are we going to add, in a different way, for revenue?
- Pat Candelaria suggested we start by cutting out our meals at each meeting.
- Additional monies will require a supplemental request
- Tim and Luanne are willing to work with us and help us
- Budget Overtime instead of adding in after the fact
- Scott McHenry expressed concern about the model currently being used related to the Saturday night concert and thought we should review that
