Virtual Meeting

PRCA

Synneva let everyone know she is working to fill out the PRCA applications and will send to John and Craig for review before sending them in to the PRCA. Craig let the committee know that the stock contractor for 2021 will be Summit Pro and the video scoreboard vendor will be Reita Creek. John reported that he had been in contact with both and they are excited to come back. Synneva said she will ask the County's Business Operations Manager to create an addendum to last year's contracts and get those sent out.

Hometown Rodeo

John read over the rule changes in the CR. Most of the changes revolve around eliminating age/gender requirements when not applicable. John said he would like to simplify a few more age groupings in a couple sections in the future. The committee approved the rule changes for 2021. The Hometown Rodeo rules will be removed from the CR and be their own set of rules.

John said the change in the order of the events was very well received. Synneva asked for clarification on what the change in the schedule was. John explained that the younger kid events were moved to the beginning of the schedule and team roping events were put at the end. That way the kids aren't waiting around all evening and competing so late at night.

Craig let everyone know that the stock contractor for Hometown would most likely be Arlin Lepp again as he has done it for years. He said he would reach out to Monty and have him contact Arlin. John let everyone know Monty is stepping down from a Director and moving to an Associate Member, but will still be active in helping to run the arena day of Hometown Rodeo. He said that the Committee will have to find people to help with the organization and tasks leading up to Hometown. John volunteered to take on the task of contacting Arlin for 2021.

Chair Recommendation

Craig announced he would like to put forward a recommendation to the Committee for himself and John to remain Co-Chairs instead of moving to Chair and Vice Chair. The Committee was in favor. The recommendation will be brought to the Fair Board meeting on 11/19 to be voted on.

Craig asked Synneva if she knew when Dean wanted the Committee to meet. Synneva said that he would have to check with Dean on that, but it is her understanding that the Committee can meet every month if they need to, but staff will only be present on the predesignated meetings.
