Every entry at a recognized show shall constitute an agreement that the person making it, owner, lessee, trainer, manager, agent, coach, driver, rider and horse shall be subject to the rules of the association, the local rules of the show. It shall further constitute that every horse, rider and/or driver is eligible as entered and that the owner and any of his representatives are bound by the constitution and rules of the show.
