Intent: The intent of this bid is to secure a vendor to provide powered amplifiers for the Tulsa County Public Facilities Authority (TCPFA). The term of this bid will be in effect for a one (1) year period beginning on the award date and have the option to renew for additional one (1) year periods.

General Requirements: Bidders shall keep the following in consideration while bidding these items:

- Bidders shall provide pricing for the following models:
 - o Crown CDi2000 2 Channel, 800 watt @ 4 Ohm
 - o Crown 5000i 2 Channel, 2500 watt @ 4 Ohm
 - o QSC CDX4.3 4 Channel, 625 watt @ 4 Ohm
 - o QSC CDX4.5 4 Channel, 1150 watt @ 4 Ohm
