## Fire Suppression System Materials Bid Specifications

**Intent -** Tulsa County Public Facilities Authority (TCPFA) is requesting sealed bids to secure a vendor to provide materials, supplies, components and equipment for the maintenance and repair of the fire suppression systems. This bid will be in effect for a one (1) year period starting on the award date with options to renew for additional one (1) year periods if both parties agree to no changes in pricing, terms and conditions.

General Requirements - Vendor shall keep the following in consideration while bidding:

- Vendor shall provide a price for each length of pipe requested.
- All pipe must be Schedule 40 Sprinkler pipe, UL and FM approved, ASTM A795 and have a corrosion resistance coating.
- Vendor shall provide a cost plus percent for any additional materials, supplies, components and equipment that may be needed to complete maintenance or repairs. Cost of materials shall be vendors actual cost plus markup percentage listed on Bid Pricing Sheet. TCPFA reserves the right to request documents listing cost from their provider.
- The Vendor shall provide materials in a timely manner.
- Vendor shall include a list of any variations from the specifications listed.

**Delivery** – Bid prices shall include freight or delivery costs to 4000 East 21<sup>st</sup> Street, Tulsa, OK 74112.
