SPECIFICATIONS FOR HEAVY EQUIPMENT

INTENT: The Tulsa County Public Facilities Authority (TCPFA) is requesting sealed bids for a Telehandler, Forklifts and a Man Lift. **TCPFA is requesting options to purchase, lease or lease-purchase these units.**

APPROVED EQUIPMENT: Vendors shall submit their selected models for approval by TCPFA no later than 5:00 p.m. on March 12, 2020. Vendor must include complete specifications with the request. TCPFA will review and respond to vendors no later than March 17, 2020. Vendors must submit and receive approval on their selected model in order to be considered for awarding.

QUESTIONS/REGISTRATION: Vendors shall submit any questions to Jessica Booth via email, <u>jessica@exposquare.com</u>, no later than 5:00 p.m. on March 12, 2020. Vendors are encouraged to register their participation to stay informed of any changes or addendums issued. Vendors shall register by emailing their company information Jessica Booth.

BID SUBMITTALS: Vendors shall submit one (1) original copy and five (5) extra copies of the bid response. Bids must be turned into TCPFA Administrative Offices no later than 11:00 a.m. on March 25, 2020. Bids may be mailed or hand delivered, but must be received by the stated time. Bid must include signed and notarized Affidavit for Filing with Competitive Bid form or bid will be rejected at the bid opening.
