Bids will be opened by the TCPFA in the Expo Square Administrative Office, 4145 East 21st Street, Tulsa, Oklahoma, 74114 at 1:00 p.m. on April 13, 2021.

"Affidavit for Filing with Competitive Bid" form must be signed, notarized, and returned with bid or bid will not be accepted.

Bid Specifications Tulsa State Fair Livestock Awards

The Tulsa County Public Facilities Authority (TCPFA) is requesting sealed bids for the production and delivery of Livestock Awards for the 2021 Tulsa State Fair.

Specifications: The Tulsa State Fair staff has chosen a belt buckle to be presented as this year's livestock award. The requirements for these buckles are below:

- Buckles must be handcrafted and have a unique custom design including, but not limited to, engraving, lettering and/or stones.
- Must be 16 gauge metal
- Shall have a German Silver and/or Sterling Overlay
- Shall have silver and/or gold plate base
- Shall have silver and/or gold trim
- Shall have hand engraved background
- Size must be 3.5" x 4.5". Bidder must indicate if submitting a buckle of a different size.
- Shall have black, copper, gold or silver background, trim and scrolls

Quantity: Approximate quantity is 210 belt buckles for the Tulsa State Fair. Order will be no less than 200 and no more than 250. A smaller order of no more than 12 belt buckles will be requested for the Live Race horse racing season.

Schedule: Order for the Tulsa State Fair will be placed no later than April 30, 2021. Art approvals must be submitted to Tulsa State Fair no later than May 10, 2021. All final art approvals will be submitted by May 14, 2021. All buckles must be delivered to the Tulsa State Fair no later than August 2, 2021.

Order for Live Race will be placed in May and delivery date will be negotiated at that time.

Delivery: Delivery of all buckles for the Tulsa State Fair must be no later than August 2, 2021. Order will be placed by April 1, 2021. Art Bid price must include freight to 4000 East 15th Street, Tulsa, OK 74112. A fine of \$100 will be incurred per day after the August 2, 2021 delivery deadline.



Sample: Bidders must include a picture of the belt buckles they intend to produce for the Tulsa State Fair. Must provide at least 5 buckle options.

Bid Questions: Bidders are required to complete the requested information and submit with their bid. Bids must contain all charges, no exceptions will be made. Bidders must submit a list of any additional charges to be expected with their bid and an explanation for each charge.
