Specifications For Tile & Granite

Intent: The intent of this bid is to secure a vendor to provide and install tile & granite for Tulsa County Public Facilities Authority (TCPFA). The term of this bid shall be in effect for a one (1) year period beginning on the award date and have the option to be renewed for additional one (1) year periods.

General Requirements: Bidders shall keep the following in consideration while bidding these items:

- Bidders shall provide a percent discount from the current published retail price list for tile, granite and any supplies related to the installation of these items.
- Bidders shall provide a per square foot price for the installation of tile or granite.
- All quotes and invoices shall reflect list price of the items, less discount, plus installation and delivery to TCPFA.
- TCPFA will initiate purchase orders on an as needed basis during the term of the bid.
- No payments or deposits will be made in advance of delivery.
- If different discounts are proposed for different items, bidder shall clearly identify what is applicable.
- Bidder shall not bid the discount any other way than what has been requested; failure to comply will result in the rejection of bid.
- Successful bidder shall provide site visits as requested to provide quotes.
- Successful bidder shall provide all tools and materials to complete installation of items. This includes caution tape, signs or any other items needed to block off areas as needed.

Insurance: The successful bidder shall provide both Workman's Compensation Insurance and General Liability Insurance coverage, with limits of not less than \$1,000,000/\$1,000,000/\$1,000,000 with excess umbrella of liability \$1,000,000 and listing TCPFA as additional insured. Certificates of insurance will be required before work can be performed.
