# VIDEO BOARD RENTALS SPECIFICATIONS

#### INTRODUCTION/SCOPE

Tulsa State Fair is seeking bids for image magnification services, to include provision of outdoor LED video screens, Cameras, Switchers, Related Equipment, as well as operators, producer, and engineer for equipment.

#### **GENERAL INFO**

Services will be needed for the annual Tulsa State Fair, September 26 – October 6, 2019. Equipment shall be set up and operational no later than Wednesday, September 25, 2019. Bid pricing shall be inclusive of all associated costs for provision of services. Charges over and above the bid amount such as per diem, meals, rooms, transportation, etc. will not be paid by Tulsa State Fair.

#### **BUDGET**

The budget for the services described shall not exceed thirty thousand dollars (\$30,000). Equipment brands and models are listed only to demonstrate level of performance and quality; actual items provided by bidder must be of equivalent or better performance and quality. Bidder shall list any equipment that varies from the equipment listed.

Bidders are welcome to include options, alternate bids or recommendations with price and equipment details for the Tulsa State Fair to review and consider.

#### **SPECIFICATIONS**

#### LED SCREENS

Two (2) outdoor rated LED video displays, one on each side of the stage. Screen size: 10' x 20' each, minimum. Total height may not exceed 22 Feet. The screens must be capable of being outdoors up to 12 days. The screens must run in direct sunlight.

## LED SCREEN SPECIFICATIONS

- 10mm or better resolution, 4500 Nits brightness
- Proper ground supported structure for outdoor use
- All necessary processing & power distribution equipment and cables
- Truck mounted LED is acceptable
- Proper wind & weather monitoring devices
