## **NO PRACTICING ALLOWED IN RINGS AT ANY TIME**

**Dogs may arrive** any time prior to their scheduled time of judging. Dogs not required for further judging will be excused.

**Judges Will Not Wait for any Dog Holding Up A Class.** Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged.

**All Dog Present** must be held on leash or confined to their crates except when being judged or when in the exercising ring.

**No gasoline or diesel generators** are permitted inside any building or within 100 feet of any tent in which this dog show is conducted.

**As specified in Chapter 12, Section 4** of the AKC Rules Applying to Dog Shows, information contained on the entry form is required to be published in the club's show catalog. This information is also subject to publication in other media.

**The Club and its Event Secretary** caution all persons entering the show site and show grounds against all hazards which may exist, including, but not limited to: Condition of the site/ grounds, parking/loading/unloading areas, entrances, floors and stairways, elevators and escalators, floor coverings, walkways, tenting/canopies, electrical appliances, cords and fittings, exercise pens, and the presence of animal. All persons should take into consideration this is a sporting event and dress, act and exercise caution appropriate for the activity involved. All persons entering the show, the grounds, site and show areas for whatever purposes do so entirely at their own risk. By virtue of entering the show, the entrant has indicated their acceptance of the terms listed in the premium list and assumes all risks involved.

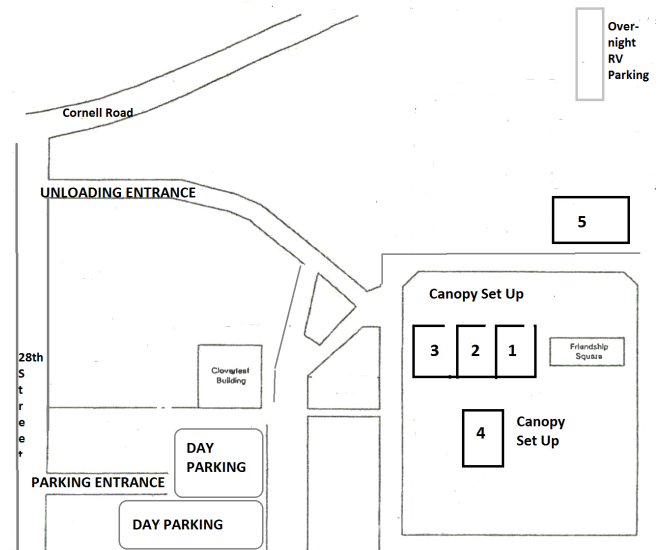

### From I-5 Southbound:

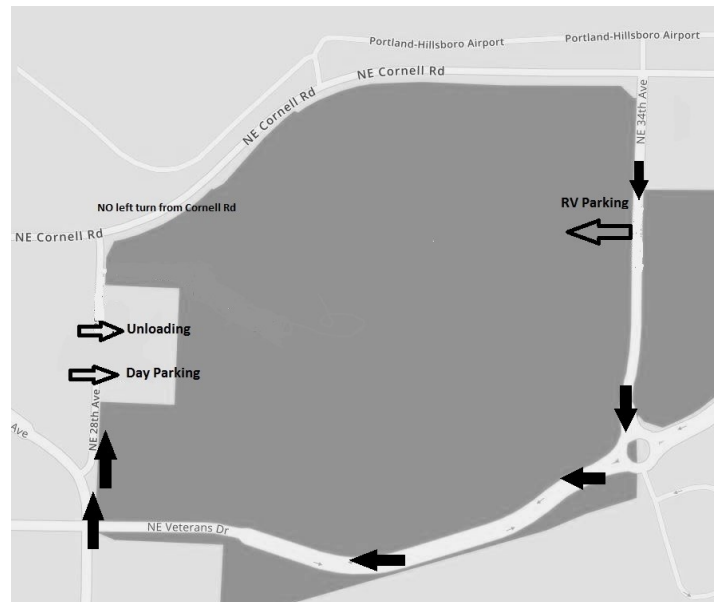
Exit 302B, I-405 South to US 26 West (Sunset Hwy.)

### From US 26 (Sunset Highway)

**Westbound:** Exit 61 A for Brookwood Parkway, turn left (south). Continue on Brookwood for appx. 3 miles, turn right onto Cornell Rd. Continue for ½ mile, then turn left at the traffic light onto 34th Ave. Continue past the construction entrance. At the traffic circle, take the first right onto Veterans Ave, continue ½ mile to the traffic light at 25th Ave. Turn right, then an immediate sharp right onto 28th Ave.

Day parking entrance is 100 yards on the right, Unloading entrance is another 200 yards up 28th Ave. on the right.

\*\*\* Overnight RV Parking ONLY – use the construction entrance on 34th Ave.
