For the Night Show we did \$10 for reserved upper seating, \$20 for reserved lower seating and \$30 for pit tickets. The Board wants to keep it all the same. Shyla asked about the stage seating. Eddie said it worked well having that reserved for sponsors. Shyla asked about Tough Enough to Wear Pink. Eddie said Saturday. Wendy is going to ask if the Derby wants us to do tickets with us again this year. Shyla asked about times of events, Eddie said Thursday and Friday Rodeos: 7:00pm gates open at 5:30pm, Saturday: 1:00pm gates open at 11:30pm, Night Show: 8:00pm gates open at 6:30pm. The Board agreed. Shyla said current Food Vendors include: our usual local organizations, Bogey's BBQ, Texas Twisters, and potentially the Wood Fired Pizza guy. Wendy said Jessica is interested in bringing coffee to the High School Rodeo and Fair.
