1. **CALL TO ORDER:**

The meeting was called to order by Ryan Edson at 6:36 PM

4. **APPROVAL OF MINUTES:**

Neisha Furtado, moved to approve the minutes of the June JLC meeting; seconded by Diane Amaro.
Motion carried.

5. **Old Business:**

JLC Need to confirm rabbit resale would like to have rabbits leave early in the morning on Sunday.

6. **New Business:**

Diane Amaro suggested the small animal round robin needs improvement. If it was moved to a different day a bona fide judge might be available. It was suggested to move FFA, 4 H non-primary to Wednesday.

7. **Butte Core FFA and out of County Participation: breeding, round robin**

After much consideration the committee suggested approving a motion to allow out of county FFA members who reside in Glenn County to sell an animal at The Glenn County Fair Livestock Auction. It would read "Glenn County Residents may sell at The Glenn County fair" even though they attend an out of county school. They would only be eligible to sell at one Jr. Livestock auction". Garrett Landry and Shelby Weinrich spoke about the value of this decision to their ability to achieve their goals within the program. It was decided to table officially making the motion until the November meeting. So that more committee members were present to weigh in on the decision.

8. **Barn Layout and Overcrowding:**

A special committee was created and will meet November first to define this rule that will be included in the exhibitor handbook if the entries exceed the barn capacity of the Glenn County Fair.

9. **Creating duty folders**

The strongest sentiment that was communicated was that the JLC has successfully gone through the transition phase and are now much more experienced and knowledgeable and it is time to create comprehensive informational binders that specifically describe the duties that different members are appointed to be responsible for at fair time, so people do not start from scratch in the future. This will be accomplished by each person dictating the details of their duties in a binder to pass on to the next committee member that will take over that responsibility.

9. **Entry Deadline (Dixon May Fair):**

The staff would like to adopt a deadline similar to other fairs where your entry will be due at the date of ownership. It would save multiple trips to the fair and we would have animal counts earlier. The committee

liked the idea but would like to inform the exhibitors about the upcoming changes and then implement them at the 2019 fair.

10. Round Robin Review.

The committee is going to review this and decide at a future meeting as to how the rules for round robin should look in the exhibitor handbook.

11. Judges:

The committee reiterated that they would like to spend additional funds on judges. The committee would like to get more out of state judges.

12. Small Animals Proof of Ownership:

In an effort to legitimize our small animal projects the committee is going to initiate more stringent ownership deadlines. The poultry leg bands, and the rabbits will need to turn in the list of tattooed animals at the ownership deadline. They need to add identifying descriptions on the sheet.

13. Feed Pass Policy:

The committee voted to assign feed passes to leaders and advisors only. This is to eliminate congestion and safety concerns on the grounds.

14. Proof Of Ownership For Breeding:

Will not change.

15. Review Exhibitor Handbook:

Changed and confirmed all dates. Will add barn overcrowding policy. Updated medical release form. Will be reviewing more thoroughly for November meeting.

16. Review deceased animal policy:

In the future if an animal does not make it to the processor the sale manager will be notified, and this person will communicate the options to the buyer. This policy will be added to the sales agreement at the auction.
