It was moved by Staci Bettencourt that the JLC would use funds to purchase a new Champion ear tagger and to order a new slap tag set with digits. This was seconded by Christina Ward.

## 10. Buyers Gift:

It was decided to continue giving embroidered hats as a buyer's gift at the livestock auction. Christina Ward will order the hats and come up with a Livestock oriented logo. CEO Newman will inquire if Tri Counties is interested in sponsoring the hats.

# 11. Special Award Reviewed:

The \$20.00 sponsorship for special awards allowed the fair to purchase a water bucket with a fair logo on it and a water brush and squirt bottle.

### 12. JLA Lighting Project:

It was decided that in the event that the Friends of The Fair sponsor the purchase of new lighting for the barns, the JLC would sponsor the labor portion of the project. The estimated cost would be \$1800.-\$2400.00 This motion was made by Val Henning and seconded by Staci Bettencourt

### 13. Thank Britt Grimmsman For Her Service:

The JLC acknowledged Britt Grimmsmans exemplary service to the JLA. She is stepping down to focus her energy on the new Glenn County Fair event The Glenn-Colusa Cattlemens Day.

# 14. Appoint New Member:

It was unanimously decided to add Ryan Edson as a new JLC member to take the spot of Britt Grimmsman. It was mentioned that he was already incredibly helpful in fair time auction duties.
