

WELCOME TO THE 2018 MISS GLENN COUNTY COMPETITION

Applications close on March 5th, 2018.

Entering the Miss Glenn County Program is a commitment of time and energy and requires young women who are dedicated and enthusiastic. They must be as interested in the experience of competing for Miss Glenn County as they are in winning the title.

Completed applications are due in the fair office on or before March 5th, 2018 by 3:00 p.m. All components of the application must be complete, including submission of an unofficial transcript. Contestants will be notified of their admission into the competition no later than March 9th. A mandatory meeting will be held on March 21st at 6pm in Flaherty Hall. One parent/guardian must attend with the contestant.

A limit of ten (10) young ladies will be accepted in the competition.

The prizes this year include:

Winner of the Miss Glenn County title will receive a \$500 scholarship

First runner up will receive a \$200 scholarship

Second runner up will receive a \$150 scholarship

Each contestant is asked to obtain a \$150.00 sponsorship. Your sponsor can be family, friends or local businesses. Each sponsor will have name recognition throughout the competition, and the contestant that wins the title of Miss Glenn County will have the opportunity to represent her sponsor throughout her year's reign.

The sponsor names and \$150 sponsorship fee need to be submitted to the fair office by March 21st. Program Directors will NOT accept any sponsorship payment; it must be turned in to the fair office. A practice schedule will be provided at the meeting listed above.

PERSONAL ESSAY

On a separate sheet(s) of paper, no more than one and a half pages, (double-spaced, Times New Roman font) respond to all the questions/statements in brief essay form. Please choose a font size and style that will enable the judges to read your essay easily. This is their first chance to get to know you. Be aware that it is also possible that your essay may be printed in its entirety in the fair newspaper. Remember ... be creative and personable, you want the judges to get a sense of you and your personality.

- 1. Introduce yourself. Tell about yourself, your family, and who you are. Be sure to include interesting information about what makes you unique.
- 2. What school activities have you been involved in? Include academic achievements you have earned.
- 3. Tell about your extracurricular activities: clubs, athletics, community involvement, etc. Include any offices held, awards/achievements, or other recognitions.
- 4. Tell about your future goals.
- 5. Explain your reason(s) for entering the Miss Glenn County competition.

Please advise the pageant coordinator of any physical restrictions that would not allow you to participate in a group dance.

RULES AND REGULATIONS OF THE MISS GLENN COUNTY PROGRAM

Completed applications are due in the Fair office on or before 3/5/18.

The Miss Glenn County competition is open to all girls regardless of race, color, or creed who meet the age and other requirements as listed below, and abide by the general rules as set forth above.

ELIGIBILITY:

- Contestants must be a Glenn County resident for at least six (6) months prior to May 2018.
- Contestants must be between the ages of 17-21 on or before May 1.
- Contestants must demonstrate and maintain a minimum 2.5 cumulative GPA.
- Attendance at ALL Queen Pageant Functions and rehearsals is mandatory.
- Contestants must never have been married or have had a child.
- The winner must not get married or become pregnant during the reign. Title will be revoked.
- Parent(s)/Guardian(s) or quest(s) of the contestants will not be allowed to attend pageant practices.
- Contestant must never have been convicted of a felony.
- Use of alcohol, drugs, and tobacco products are prohibited on fairgrounds, during fair events, and
 events where she will be representing Glenn County and while serving as a representative of the program.
- Contestants cannot have previously held the title of Miss Glenn County.
- Each contestant must agree to work a certain number of hours at the Fair. Duties will include, but are not limited
 to: giving out ribbons, awards, and making appearances at fair events. The hours will be determined by the Fair
 Board and the Program Directors. Contestants will receive their prize money after they have completed their year
 of service. Titleholders will be required to attend a number of event throughout their year of reign. The events will
 be determined by the Fair Board and Program Directors. Failure to complete your duties will result in NONPAYMENT OF PRIZES.
- Attendance at all fair duties is MANDATORY. Please be sure to notify all employers and/or other obligations of this before committing to the program.
- When representing the fair, conservative and tasteful attire is expected.
- In the event contestant winnings exceed \$600.00, a social security number will be requested.
- Contestants must have the applications completed with the Rules and Regulations signed by themselves and their legal parent/guardian.
- One parent/guardian of each contestant must attend the parents' meeting on March 21st, 2018. The meeting will be at the Glenn County Fair Grounds, Flaherty Hall at 6pm. A practice schedule will be provided at the meeting listed above.

A limit of ten (10) young ladies will be accepted in the competition.
