### Rules:

1. NEW IN 2019: Individuals may compete twice with a different partner
2. Teams are to consist of 2 individuals
3. Two pens set with a 12-16-foot opening in the middle
4. Cattle will be numbered 0-9
5. The team will line up in the opposite pen from the cows using the gate between the pens as a start line. Time will start when the horse's nose crosses the gate and you will be given a number to start. Sort your cattle in order of number given until you are finished or time runs out.
6. Your time will be called if a sorted cow comes back across the start line or the wrong number goes thru the line.
7. 90 second time limit
8. Fastest time and the most cattle sorted wins the event.
