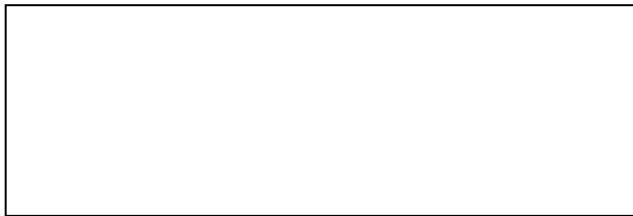

Welcome to the Glenn County Fairgrounds RV park. We ask that while staying at the Glenn County Fair RV park you observe the following rules and regulations of the RV park.

Fair Time Camping Rate:
With Utilities : \$350
Dry Camping: \$150

Non- Fair time Rate: \$25 rig/night (please complete form and turn into fair during office hours, after hours please insert into door slot on east side of fair office)

Rules:

Speed Limit: 5MPH

Quiet Hours: 11:00pm – 6:00am

Permits are required for RVs and all vehicles, and must be displayed.

Drugs, weapons, fighting, lewd conduct, reckless driving, speeding are not permitted.

Selling, advertising, or distribution of any product (including alcohol) is prohibited.

Non-contained fires for cooking or heating are not permitted.

Any type of fencing, barriers, pallets, and etc. are not permitted.

Pets are to be controlled either by a leash or voice command.

Pets are prohibited from the restrooms.

Pets are to be cleaned up after; failure to do so may result in eviction.

Any individual who becomes a nuisance will be asked to leave the grounds.

All occupants and guests must obey all posted rules, as well as any direction given by the Glenn County Fairgrounds security. Failure to comply with the fairgrounds regulations can result in eviction or other action.

The fair determines trailer layout during fair time to best optimize the space available.

Use of the facilities and equipment will be at the guest and visitors own risk. Neither the owners nor the management can be held responsible for accidents, injuries, or loss of property due to
