



Minor Release of Liability

PLEASE READ CAREFULLY BEFORE SIGNING. THIS DOCUMENT INCLUDES A RELEASE OF LIABILITY AND WAIVER OF CERTAIN LEGAL RIGHTS.

The undersigned hereby represent and warrant that they are the parent(s) or guardian(s) of _____ ("Minor").

In consideration of the Minor being permitted to participate in any way in _____ and related events and activities associated with it, which is to be held on _____, 20____ ("Event") and will be conducted by the Greeley Independence Stampede, the undersigned, for themselves and the Minor, their spouses, legal representatives, heirs, successors, and assigns (collectively, the "Releasers"), hereby release, waive, and discharge the Greeley Independence Stampede, its directors, officers, members, promoters, sponsors, advertisers, owners, and any other parties who may have liability to the Minor or Releasers for injuries of damages sustained by the Minor or Releasers and caused by the Event (the parties released shall be collectively referred to as the "Releasees"), from all liability to the Minor and/or the Releasers for any and all loss or damage, any claim or damages resulting from the Event, or successors, and assigns for any and all loss or damage, any claim or damages resulting in death of the Minor, whether resulting in whole or in part by the negligence of the Releasees, or otherwise while the Minor is participating in the Event.

On behalf of the Minor and themselves, Releasers acknowledge that the Event is a dangerous activity and that participation in the Event exposes the Minor to a substantial and serious risk of property damages, personal injury, or death. Releasers acknowledge that Minor's participation in the Event will involve such a hazard. Being fully aware that participation in the Event will expose the Minor to risk of property damages and/or personal injury or death, Releasers, on behalf of the Minor, voluntarily assume all risks from the activities involved and hereby release the Releasees from liability for any and all property damages, personal injuries, or other claims arising from participation in the Event, including claims that are known and unknown, foreseen and unforeseen, future or contingent. Releasers shall not now or at any time in the future, directly or indirectly, commence or prosecute any action, suit, or other proceeding against any or all of the Releasees arising out of or related to the actions, causes of action, claims, and demands hereby waived, released or discharged by Releaser(s), personally and for the benefit of the Minor. This provision shall be binding upon Releasers and the Minor.

Releasers hereby agree to defend and indemnify Releasees and to hold Releasees harmless from any liability, claims, demands, causes of action, loss or damage occasioned to the Releasees, or any of them, arising from the Minor's participation in the Event or any breach by the Minor or Releaser(s) of any obligations or covenant of Minor or Releasers hereunder.

WARNING
