

Kosciusko County Fairgrounds Camping Information and Rules

Payment, Check-In & Check-Out

- All campers must register in the fair office or fill out and deposit their camping registration form in the drop box provided in front of the fair shop upon arrival.
- Payment can be made with cash or credit cards. Checks are not accepted. Payments are accepted at the Fair Office.
- Guests must pay for camping spaces according to the fee schedule. If you have any questions, consult with the fair office.
- Payment must be received by 10 a.m. or within an hour after arrival to the campground.
- Checkout time is 12:00pm the morning following a paid night's stay. Late checkouts are permitted for an additional fee [min. \$15].

Reservations

- The campground does not accept reservations, **except for 15 sites or more**. Camping is on a first-come, first-served basis. All existing reservations for 2015 will still be honored.

Camping Rules and Regulations

1. **Tent camping and** secondary tent with RV's must be approved by Fair Management.
2. No one under the age of 18 will be allowed to rent a space without an adult.
3. Quiet hours are from 11 p.m. to 8 a.m. Minors under the age of 18 must be in their campsite during quiet hours. Please respect other campers.
4. Parents are responsible for the safety and supervision of their children. All minors in the camping area must have adult supervision at all times. Adults must accompany minors in campers overnight. No unsupervised play allowed.
5. All trash must be properly disposed of in the receptacles provided.
6. Grey and black water must be dumped at the dump station.
7. **Absolutely NO** Auxiliary Motorized Vehicles, ATV's or Golf Carts are permitted on the grounds without authorized permit from the Kosciusko County Fairgrounds Fair Office. Rollerblades, skateboards, bicycles, scooters, etc., with prudent use, are allowed on the grounds. However, during special events, all wheeled apparatuses are prohibited from the event sites. Exclusions for handicapped wheeled apparatuses and fairground business only by permission from the Kosciusko County Fairgrounds Fair Office.
8. All dogs shall be under control and at your campsite on a leash not to exceed 10 ft. Owners will be responsible to clean up after their pets and dispose of it properly. Animals creating a disturbance or running loose will be removed from the fairgrounds.

9. It is unlawful to destroy or remove Kosciusko County Fairgrounds property or equipment.
10. Campfires are only permitted in fire rings. Cutting trees or branches or gathering of firewood is strictly prohibited. Do not build fires under trees!
11. All designated roads and driveways are required to provide a clear egress route and must be kept clear and open at all times. Vehicles and objects encroaching into or blocking any portion of these egress routes will be towed or removed at owner's expense. This is to accommodate fire, emergency and police traffic. Intentionally blocking of roads and driveways will be grounds for eviction from the fairgrounds.
12. Alcohol is permitted on the grounds for personal consumption only and by those of legal drinking age (21 and Older). No sales of alcohol will be permitted. The Fairgrounds will not be responsible for any alcohol related injuries or problems on the grounds or by anyone who has consumed alcohol on the grounds and then left the grounds. **Alcohol is not permitted outside your campsite. Absolutely no alcohol in public areas. Misuse of alcohol will not be tolerated.** All consumers of alcohol are asked to adhere to common sense when drinking and to remember that the responsibility for any problems resulting from their alcohol consumption lies with the consumers. If the Fairgrounds personnel feels that someone has become a public nuisance due to over indulgence of alcohol the Fairgrounds has the right to call the law enforcement and have that person removed from the grounds with no refunds given.
13. No Illegal Drug use or possession is allowed on the fairgrounds.
14. Abusive language, threats or physical violence directed to another camper, staff or director is not permitted and is means for immediate eviction and permanent expulsion from the fairgrounds.
15. The Fair Board reserves the right to refuse service to anyone. Fair Board is not responsible for accidents, injury or loss of any kind. Guests agrees to indemnify and hold harmless, Kosciusko County Community Fair and its agents for any and all damages, loss, claims, cost of expenses, including attorney's fees, which KCCF and/or its agents may suffer or incur or become obligated to pay pursuant to claims by others suffered or arising out of you or any of your guests acts or omissions.
16. Camping is at your own risk.
17. Please be aware that there may be events on grounds during your stay.
18. The Fair Board reserves the right to ask any person or group to leave the fairgrounds.
19. The Kosciusko County Fair Board has the right to add to, change or modify these rules without notice.
20. The Kosciusko County Fair Board and its agents reserve the right to interpret and enforce all the rules for the benefit and safety of all.
21. By entering Kosciusko County Fairgrounds and/or paying any fee, guests agree to the above rules and conditions. Guests agree to be responsible for the repair/replacement cost of any damage, and they may be immediately evicted from the property for damage or violation of the rules. **NO REFUNDS FOR ANY REASON.**
