Class Rules

- All animals must have a current Health Certificate from an accredited Vet if from out of State.
- Ethical treatment of animals: All animals are expected to be treated in an ethical and humane way. Failure to do so may cause the exhibitor and animal(s) to be disqualified.
- Prospect Steers will be weighed Sunday May 19 7-9am.
- Prospect classes will be determined by weights
- Open Class will be determined by age (see class list)
- All heifers must be 24 months or younger
- There will be breed divisions based upon entries received
- There must be a minimum of 5 animals in each division to make separate classes, otherwise there will be a combined class.
- The judge's decision is final.
- Generators and Wash Racks: It is the responsibility of the exhibitor to provide his/her own power for cooling and grooming their animals. There is a limited supply of water and wash rack facilities.
- Day of show entries will be accepted with late fee.
