ALL SIGNATURES MUST BE PRESENT BEFORE ENTRY WILL BE ACCEPTED

We, the exhibitor and parent/guardian have read, understand and will comply with all the rules and regulations set forth by the State Fair of Louisiana; those to include but not limited to, the General Rules and Regulations, the Show Ring Code of Ethics, the Junior Division General Rules and Regulations and all special rules of the Livestock Exhibitor Handbook specific to each animal entered. We agree that we will be held **strictly liable** for any violations of the aforesaid rules and regulations. We expressly waive any all rights to notice or protest or hearing regarding enforcement of the aforesaid rules and regulations. We agree that all actions of the State Fair of Louisiana management regarding the rules and regulations are final and not subject to dispute.

We, the exhibitor and parent/guardian, understand the use of any drug, chemicals and/or compound that are not approved by the Food and Drug Administration for use in meat producing animals, the illegal use of approved drugs, chemicals and/or compounds and the use of any drug/medication/treatment that gives an animal an unfair competitive advantage is prohibited. All animals shall be subject to test, (blood, urine and tissue), for drugs or foreign substances. All animals must remain free and clear of ALL drugs and chemical residues while on show grounds. A positive test will result in disqualification, forfeiture of any premiums and/or awards and will exclude the exhibitor, organized group or any individual involved from future competition at the State Fair of Louisiana. The opinions, test results and the conclusions reached by the testing laboratory used by the State Fair of Louisiana for these test shall be final and binding upon the Exhibitor, without protest or recourse against the State Fair of Louisiana. The Exhibitor understands and agrees that he is not entitled to any independent testing or to submit any blood, urine, tissue or other samples to any other laboratory, and the opinions, test results and conclusions reached by the testing laboratory used by the State Fair of Louisiana are final and binding and shall not be contested by Exhibitor and this is an express condition to Exhibitor's participation at the State Fair of Louisiana.

We, the exhibitor and parent/legal guardian, understand any DNA sample collected during the State Fair of Louisiana that does not match the submitted nomination sample or contaminated hair samples without follicles attached for said animal will result in disqualification, forfeiture of any premiums and will exclude the exhibitor, organized group or any individual involved from future competition at the State Fair of Louisiana.

We, the exhibitor and parent/legal guardian, grant permission to be photographed or interviewed in connection with the State Fair of Louisiana Shows and Special Events. We understand that such photography or interview may be used by the released parties for television, film, video, visual, graphic or printed media.
