A smiling individual who displays charm is a standout regardless of age or training. The search is on to find representatives to reign as Queens of the Lake County Fair. ***Scores** will not be given and parents should not approach the judging panel.

Sunday dress, pageant dress or special occasion attire is fine. If entering photogenic, bring photo no larger than an 8x10 unframed, which will be returned at the pageant. Three additional photos may be entered for \$10.00 each. ***All** contestants receive participation awards. Each division winner receives a trophy, crown and sash. Two runner ups in each age division receive trophies. Optional winners receive trophies.
